- In July 2020, Expertmedia, Sonema's technical subsidiary, once again validated its **compliance with PCI DSS V3.2.1 requirements** at "Level 1 Service Provider" level defined by the international *Security Standards Council*. This compliance enables Sonema to host electronic payment platforms and to position itself as a trusted third party for various banking and electronic payment services.
